

CONSENT

for personal data processing

This consent for personal data processing is a public offer. By registering himself/herself or a minor child to participate in the The Mendeleev International Student Competition (hereinafter referred to as the Contest) on the website <https://mendelevsociety.ru/membership/konkurs-mk-eng/> an individual (hereinafter referred to as the User) gives his/her consent to the processing of personal data / personal data of a minor child (hereinafter referred to as the Consent) pursuant to Federal Law No. 152-FZ "On Personal Data" of July 27, 2006.

The personal data operator is the A.N. Frumkin Institute of Physical Chemistry and Electrochemistry of the Russian Academy of Sciences (Principal State Registration Number 1037739294230, address: 119071, Moscow, 31 Leninsky Ave. (prospekt), bldg. (korpus) 4) (hereinafter referred to as the Operator), which processes personal data in the Contest registration system, and as part of providing the services agreed upon by the User and the Operator, in compliance with the requirements of the Constitution of the Russian Federation, federal laws and other statutory regulations governing the processing of personal data.

The list of personal data, for the processing of which consent is given, including but not limited to: last name, first name, patronymic, date of birth, place of birth, citizenship, identity document details, telephone number, email address, educational institution (name, address), class/year, full name of the academic supervisor, telephone number and email address of the academic supervisor.

The purpose of personal data processing is participation in the Contest hosted by the Operator.

This consent is given for performing any action (operation) or a series of actions (operations) completed with the use of automation tools or without the use of such tools involving the personal data specified above, including collection, recording, systematization, accumulation, storage, clarification (updating, modification), extraction, use, transfer (distribution, provision, access), depersonalization, blocking, deletion, destruction of personal data.

The Operator shall take the necessary legal, organizational and technical measures or ensure their adoption to protect personal data from unauthorized or accidental access thereto, from destruction, modification, blocking, copying, provision, distribution of personal data, as well as from other illegal actions in relation to personal data, and also undertakes to maintain the confidentiality of personal data.

The Operator shall be entitled, among other things, to provide access to personal data to employees, contractors, agents of the Operator, as well as to upload, store, process personal data, also in databases, electronic systems of the Operator, including the Internet, during the period stipulated by the legislation and/or local regulations of the Operator.

There are no prohibitions and conditions for processing and distributing the specified personal data.

Personal data is processed pursuant to the provisions of Federal Law No. 152-FZ "On Personal Data" of July 27, 2006.

This Consent shall enter into force upon its signing by the User and shall be valid for 3 (three) years. The User is notified of his/her right to revoke this Consent at any time. Revocation shall be made by a written application of the User pursuant to the procedure stipulated by the legislation of the Russian Federation and/or by e-mail to: mk@mendelevsociety.ru. The User hereby confirms that his/her participation/participation of a minor child, of whom he/she is the legal representative, in the Contest will be impossible in the event of revocation hereof.
